4. Weekly Worship Average Attendance: Average number attending the weekly (primary) worship service(s) in person for the weeks your congregation met during the 2019-2020 reporting year. If not kept, use your best estimate.
5. Sunday School/Bible Study/Small Group Average Attendance: Average number attending Bible Study in person each week for the weeks your congregation met during the 2019-2020 reporting year. This may be a Sunday School class, Bible Study, Small Group, or similar group. Include all ages from babies to adults but not counting anyone twice. If not kept, use your best estimate.
6. VBS ENROLLMENT: Number enrolled in Vacation Bible School for your congregation.

Largest Ethnic Group: White (Non-Hispanic), Black (African-American), Hispanic, Native American, Korean, Chinese, Other Asian, Haitian or Other.

Year Organized: Year congregation organized for the first time.

Church: An identifiable body of baptized believers that meets regularly for Christian worship, discipleship, fellowship, evangelism, and ministry and is autonomous: self-determining, self-sustaining, and self-propagating. (A new corporation intended to operate as a church might not yet meet all these tests, but might meet the church-type mission definition below).

Church-type Mission: An identifiable body of baptized believers that meets regularly for Christian worship, discipleship, fellowship, evangelism, and ministry, but has not yet become an autonomous church.

Reporting year: The 2019-2020 reporting year is the 12 month period included in this report. In many cases this will correspond to the associational year. Membership and enrollment should be given as of the last day of the reporting year.

7. UNDESIGNATED RECEIPTS: Total amount of all undesignated gifts given by individuals. Undesignated receipts are gifts which the congregation decides how the money will be spent (by its budget or other means). This includes regular budget offerings and loose monies from the offering.
8. TOTAL RECEIPTS: Total amount of all money received by the congregation. This amount should be the total of undesignated gifts, designated gifts, and other receipts (may include income from rentals, day school or kindergarten fees, savings, pastoral aid, parking fees, etc.). **(Item 8 should be equal to or larger than Item 7).**
9. COOPERATIVE PROGRAM GIVING: Total amount of all money given through the Cooperative Program during the 2019-2020 reporting year.
10. ANNIE ARMSTRONG EASTER OFFERING: Total amount of money given during the 2019-2020 reporting year to the Annie Armstrong Easter offering for North American missions.
11. LOTTIE MOON CHRISTMAS OFFERING: Total amount of money given during the 2019-2020 reporting year to the Lottie Moon Christmas offering for international missions.
12. GREAT COMMISSION GIVING: Total amount of all money given to all Southern Baptist mission causes by the congregation. This includes monies given to: Cooperative Program (Item 9), Annie Armstrong (Item 10), and Lottie Moon (Item 11) PLUS monies given to associations, state conventions (such as a state mission offering), and any other Southern Baptist mission cause.
13. TOTAL MISSION EXPENDITURES: Total amount of all money given to Southern Baptist and non-Southern Baptist mission causes by the congregation. This includes Great Commission Giving (Item 12) PLUS any additional monies expended for non-Southern Baptist mission causes. **(Item 13 should be equal to or larger than Item 12).**
